CALL MEETING TO ORDER: Dr. Zumwalt, Chairman called the Iroquois County Public Health Department Board of Health Finance Committee meeting to order at 1:29pm on Wednesday, September 7th, 2022, in the Iroquois County Public Health Department Administration Office. Roll call was taken.

APPROVE AGENDA: Mrs. Breymeyer made a motion to approve the agenda. Motion seconded by Mrs. Offill and approved by voice vote.

REVIEW AND APPROVAL OF CLAIMS FOR AUGUST 2022: A claims listing for August 2022 was distributed for review and approval. The committee discussed a new claim with Promise Healthcare in Champaign. Discussion was held regarding Moms Meals. Dee Ann Schippert, Administrator, said as long as clients don't have access to peace meals, they would be eligible for Moms Meals. Mrs. Lisa Breymeyer, Vice Chairman, followed up by asking if ICPHD would still be providing food to families in isolation from Covid-19. Dee went on to say with the CDC changing quarantine guidance, from 14 days down to 5 days, the option was not written into the new grants. Mrs. Breymeyer moved to approve the claims for August 2022 as presented. Motion seconded by Mrs. Offill. Motion approved by roll call vote: Aye- Lisa Breymeyer, Barbara Offill, Dr. Zumwalt.

REVIEW FINANCIAL DATA FOR AUGUST 2022: A copy of ICPHD's cash balance as of September 7th 2022, was distributed for review. Discussion was held.

OLD BUSINESS: A copy of the ICPHD grants and contracts list along with a summary report of programs through August 2022 was distributed for review. Discussion was held regarding old cases that came up during the month. Dee Ann Schippert explained that with the warm weather brings animal bites and certain bacteria to the forefront. Specifically, from Campylobacter. Discussed as simple food poisoning from outdoor dining such as a picnic. Mrs. Breymeyer then inquired about one TB case. Dee Ann Schippert detailed the chest X-ray as negative and the start of latent TB medicine. Further discussion was held regarding positive Hep C cases in the area and what ICPHD could do to help. Dee Ann Schippert explained how ICPHD could reach out to the state to help acquire medicine for local residents. Jail inmates were also brought up for discussion. There is no fee at this time for county inmate examination but there is information coming to light that the county jail could house US Marshal inmates. Discussion was held on what the ICPHD would do, what services could be offered, and at what price.
